- (i) your application will be assessed and if successful, you will be required to:
- complete a Funding Deed online through SmartyGrants.
 - upload an invoice & a copy of your public liability insurance within your Funding Deed.
 - Invoices should be addressed to:

(ii) If your organisation is registered for GST your invoice will be for the grant amount + GST on the invoice you provide.

(iii) Councils will be required to submit an invoice excluding GST.

Your submitted Funding Deed will be reviewed and if no additional information is required, it will be approved for execution.

Once executed, you will receive a signed copy of the Deed for your records. You should keep these records safe for a period of seven (7) years, in the event that your project is ever audited.

Payment will be released into the bank account supplied in the Funding Deed.

Completion reports are required to be submitted 3 months from completion date of the Show.
